- Mr. Herrera presented Peter Wright representative from the Foundation and Lieutenant Colonel Schepens, who has 29 years in the National Guard and graduated from Bernards High School. They discussed in concept an outreach plan for the veterans returning from combat who may need to be retrained. The plan discussed included the Technology Institute providing educational opportunities for the Military Veterans. Lieutenant Colonel Schepens explained that although the "tuition waiver program" is not available for the Technology Institute, further discussion should ensue. Mr. Dragotta noted his support of such as he explained to the board the GI Bill enabled him to go to college and that he is still benefiting from the program.
- Mr. Herrera next presented Shawn Clark and Kevin Sliker. Mr. Clark and Mr. Sliker discussed how students from the Somerset County Vocational & Technical Schools Building Trades program can earn a vocational certificate endorsed by the New Jersey Department of Labor and practice their newly acquired skills at the Carpenter's Training Center in Kenilworth prior to becoming union apprentices.
