## O. Superintendent's Update

- Mr. Maddaluna discussed the Summer Institute which is being offered through the Foundation in cooperation with local businesses and industry. The local businesses and industry will not only provide teacher training but will also pay the teachers to attend. Mr. Herrera reported that at this time we have received seven applicants.
- The Open House is scheduled for Saturday, February 9<sup>th</sup>. Flyers were included in the board packets.
- Mr. Maddaluna informed the board of the implications of the new school funding law as there are no
  monies set aside for post-secondary and adult continuing education programs. Dr. Braun noted we
  should expect a 2% increase in State aid.
- The following administrative staff updated the board on their respective plans of action:
  - Dr. Michael Illuzzi, Director of Post-Secondary Education Programs, discussed the
    coordination of high school and Technology Institute programs to facilitate a dialogue,
    review common programs and the alignment of skills. From there, he identified one shared
    program, health occupations, which will focus on working together on joint lesson plans to
    ensure the aforementioned. Successful implementation of this experimental iniative will
    expand mutual understanding and establish more cooperative efforts.
  - 2. Sherman Harris and Pamela Brink discussed Linkages, TOPS and Crisis Management. Ms. Brink discussed the restructuring of the crisis management team members to coordinate responsibilities. The high school, Technology Institute, business office and entire campus participated in a bomb threat drill. The team reviewed and updated their procedures based on feedback and included minor items per state requirements. She also reported on the relocation of the drop-in center; plans are in the works but it has not been necessary to relocate as the restaurant program has not yet been expanded. Mr. Harris discussed the TOPS program and students. The TOPS program is working on continuing to provide exemplary services for the students by constructively and constantly meeting with the students. Mr. Harris noted the students are intelligent; they need to develop their character. Having the Linkages services located within the TOPS area is also a benefit for those students and further enhances the program.
  - 3. Diane Ziegler, Director of Curriculum and Instruction, reviewed the staff evaluation process and how it has been "retooled". The forms were outdated, the "checklist" method was abandoned and a "narrative" method was created. The optimal evaluation will also include a portfolio which will be attached to the evaluation report. A master list of evaluations (who, when, etc.) will be organized which will help to streamline the process.

- There will also be a standardized Professional Improvement Plan (PIP).
- 4. Dr. Joseph Petrosino, Supervisor of Special Needs, noted the County prides itself on sharing services. He then presented a Power Point presentation of special education student cost data and the proposed career centers between Somerset County Education Services Commission and Somerset County Vocational & Technical Schools. Mr. Maddaluna discussed the support conceptually and financially from those with vested interests. Mrs. Ventantonio asked if Quick Check is the organization that is interested in donating equipment for the program. Mr. Maddaluna confirmed.
- 5. Bernice Wicks, Director of Communications and Public Relations, distributed fliers including pamphlets, handouts and various documents detailing different forms of marketing and advertising. Dr. Braun suggested using the website to link tradesmen with the district. Discussion ensued. Mr. Herrera will be consulting the board attorney and the Foundation on such. Mr. Smith added this is exciting and that the Foundation will be a good support. Mr. Hyncik was amazed at the breadth and the magnitude of what we offer. He questioned how well is the district received by the sending districts and further suggested putting this material in the hands of the parents, not so much the guidance counselors. He shared his thoughts that passion is lost in public schools; the individualized attention of this organization can address student's issues. Mr. Ciattarelli asked if we compete with districts and felt we should focus more on the traditional vocational programs. Dr. Braun added there is pressure from the parents for students to attend colleges and quite frequently these students are not prepared. Dr. Braun concurred that the district's unique mission is educating students in a wide variety of diverse programs that lead to multiple career paths.
- Peter Carey, Director of Student Services, first shared with the Board that his lifelong mission is to deal with and change the stereotype of vocational high schools. He then digressed for a few moments and shared with the board highlights from his recent international SkillsUSA convention in Japan. What he brought back from this convention was the importance to: combat negative influences by showcasing excellence; bring business and industry in to the district to insure that the curriculum is in line and that business and industry care about our students and how competing in local, national and international competitions can be life changing events. He also noted the importance of continued financial support from government and training for the global market. Mr. Carey then presented his administrative update on the Academy for Health & Medical Sciences: He discussed the following six goals: assess effectiveness, institutional planning and coordination with Raritan Valley Community College, business and industry involvement, parent advisory committee participation; budgetary planning within the three institutions (high school, Technology Institute and Raritan Valley Community College); and staff development, advisement and enrichment programs. Teresa Morelli (English), Maria Johnson (science) and Kathy Fortunato (mathematics) shared information of their students' clubs, activities, creations and accomplishments. On February 4, 2008 at 6:00 p.m. on Channel 12 there will be a documentary about the Academy.
