K. Superintendent's Update

Mr. Maddaluna informed the board that Maureen Stivala is currently in the process of completing her doctorate.
 He also updated the board on the need to revise the Office Occupations program curriculum and upgrade the facility.
 He discussed the National Academy for Business and Finance" and how applying this model would help to better challenge the students academically and overall improve our program.
 Mrs. Stivala also explained

that this program model includes an assessment of community needs. Ms. Stivala also discussed that business programs in non-vocational high schools are some of the first programs eliminated during budget reductions, and therefore, the Somerset County Vocational High School is providing a valuable career opportunity for these students.

- Dr. Jackson of the Northwest New Jersey Community Action Program (NORWESCAP) program recognized and acknowledged Mr. Maddaluna, Mr. Herrera and Dr. Urban for their assistance and involvement in this initiative. She also acknowledged the ten corporations that will be partnering with the district in this program. The program will focus on career education for low income families in Somerset County. Twenty five families will participate in the program with a goal that these families remain out of poverty for five years. The challenges of this program are to provide transportation and childcare, change the attitudes and behaviors of these families, and in addition, provide health and mental well care. Dr. Jackson further explained the specifics of the program via a Power Point presentation. Dr. Braun asked Dr. Jackson what the poverty limits and upper age limits are. She responded \$15,000 for a family of four and there are no age limits.
- Mrs. Stitley reported to the board on the Nursing Program. She provided a list of program offerings to the board and reviewed the successes of the students. She discussed the testing requirements for the dental assistant, medical assistant and nurse aid programs. She also noted it is difficult to find instructors for the nurse aid program. Mrs. Stitley explained that the high school program coordinates with the Technology Institute program for the long term care component of their program. Mrs. Stitley was also pleased to report that last year's students from the Technology Institute achieved a 100% pass rate. Dr. Braun questioned if a list of certified instructors and evaluators can be purchased from the State; Mrs. Stitley confirmed such is available and the district does purchase such a list. Mrs. Ventantonio understood we could receive the grant two years in a row; but questioned if we could receive the nursing grant after skipping a year; Mrs. Stitley confirmed this has been the practice. Mr. Hyncik added the many job opportunities available in the business of long term care and he also noted that although the insurance companies reimburse for such long term health care providers, they do not locate such certified individuals. Mr. Hyncik suggested that the district contact Genworth Financial for their help in placing students.
- "The Academy", which is a seven minute highlight of the Somerset County Academy for Health & Medical Sciences was a segment on the cable TV program, *NJ Classroom Closeup*. A copy of this segment was shown to the board members at this meeting.
