L. Superintendent's Update

- Ms. Ziegler summarized and highlighted for the Board the Quality Annual Assurance Report (QAAR) and the High School Proficiency Assessment (HSPA) results. The public was given an opportunity for questions. There were no comments or questions.
- Mr. Herrera presented the Violence & Vandalism Report and noted that the early intervention program and other coordinated efforts of our staff have had a direct impact on the number of reportable incidents. The public was given an opportunity for questions. There were no comments or questions.
- Mr. Maddaluna provided the Board with a copy of the memo responding to Freeholder Jack Ciattarelli's request for information on the district's (a County Taxpayer-Funded operation). Mr. Ciattarelli summarized what transpired at the meeting. He was pleased with the level of support documentation provided by Mr. Maddaluna and Ms. Strober on the district's operational policies and procedures. Mr. Ciattarelli was comfortable with the district's conformance to laws, policies and regulations and informed the Board he will put the same in writing.
- Dr. Illuzzi updated the Board on the status of the Middle States approval process for the Technology Institute. There will be a self study and assemblance of data efficiency and affectivity.
- Mr. Maddaluna reported on Legislator's Day 2007 at which time the school funding formula was discussed. Presentations were given by our law enforcement and performing arts students.
- Mr. Herrera and Mr. Wright, Somerset County Business Partnership Shared Services Administrator, discussed
 the development of a program to educate educators in coordination with local businesses throughout Somerset
 County. They are looking to offer the program next summer which would pay teachers to attend a two week
 program during the summer.
- Mr. Maddaluna attended a board meeting of the Somerset County Educational Services Commission. The
 purpose of the meeting was to discuss the design and cost of the renovations to the warehouse which will
 accommodate low functioning special education students. The Career Center project is expected to commence
 September 2009.

Remarks from the Public

- Mr. D'Alonzo, retired Superintendent, heard the "rumor" that Mr. Moncrieff Fisher was retiring and this meeting was to be his last meeting. Mr. D'Alonzo was compelled to be present at this last meeting as Mr. D'Alonzo was present at Mr. Fisher's first meeting. He also thanked Mr. Fisher for his support over the years.
- Mr. Graf who had also been employed in the district during Mr. Fisher's presidency shared Mr. D'Alonzo's sentiments. He informed the Board and those present at the meeting that there will be a retirement celebration on Wednesday, December 5th at The Imperia from 5-8 p.m. in honor of Mr. Fisher. More information will be

forthcoming.

- Mr. Jones wished Mr. Fisher and his family much health and happiness during his retirement.
- Mr. Harris noted Mr. Fisher was a positive role model and a blessing to the district.
- Mr. Kuschyk on behalf of the Building and Grounds department expressed his appreciation and stated without Mr. Fisher's support we wouldn't be sitting here (in the recently constructed technology center addition where the monthly Board meetings are held) right now.
- At this time, Mr. Maddaluna presented Mr. Fisher with the gavel and block Mr. Fisher used to preside over the meetings the past years as President. Also presented was the engraved plaque that will be mounted on the block.
- Mr. Ciattarelli, on behalf of the Freeholders, said Mr. Fisher set a precedent in terms of outstanding performance
 as President of the Somerset County Vocational Board of Education. As a result, it will be a challenge for the
 Freeholders to find his replacement.

He thanked everyone for their support over the years and felt he was leaving at a time when the district is making progress to improve and expand instructional programs. He also wanted to pass onto the Board his belief of the importance for educating much needed skilled workers in the trades.
