The students, Maria Bender, Clarissa Lin and Jay Kanduri shared their experiences of the trip to the national SkillsUSA championship competition held in Kansas City, Missouri in which they won a gold medal in the agricultural and natural resources division. The students discussed one of the presentations which dealt with using alternative fuel sources (vegetable oil) in diesel engines. Mr. Jones was presented with the gold medal from this competition for display in the high school. Mr. Ciattarelli is looking to prepare a citation for the students on behalf of the Freeholders acknowledging their successes and achievements at the national SkillsUSA competition.
