- Harassment/Intimidation/Bullying Report Three new cases; two considered HIB and one considered a conflict.
- SCVTS Education Foundation Update The Foundation is reconfiguring the membership and has appointed Peter Carey and will be looking to appoint new members. Dr. Harttraft has requested the Foundation's financial support to send our gold medal SkillsUSA state winners to compete nationally in Kansas City.
- Funding Update The Somerset County Freeholders have reinstated the Health and Human Services funding of \$104,000 for the district's Twilight Program.
