### B. PSA Terms and Conditions – 2012-2013, 2013-2014 and 2014-2015 School Years

On recommendation of Dr. Harttraft and motion by Dr. Braun, seconded by Mr. Dudeck and on roll call vote, the Board of Education approved the terms and conditions of the Principals and Supervisors Association of the Somerset County Vocational & Technical Schools (PSA) for the 2012-2013, 2013-2014 and 2014-2015 school years as negotiated by the board attorney and PSA representatives; contract and salary guide to be finalized and presented at the August 27, 2012 board of education meeting.

Mr. Hyncik summarized what was agreed upon at the meeting he and Mr. Dudeck had with the PSA representatives, Maria Johnson and Duane Wallace. Mr. Hyncik reported to the board on two of the terms and conditions agreed upon at that meeting: salary increases for the three years will be 1.9%, 2.0%, 2.0% and an option clause that the board will buy back up to three vacation days for each year in this contract. Mr. Hyncik made it very clear at the meeting with the PSA representatives and at this special board meeting that this clause will sunset at the end of this contract. Mr. Hyncik noted that the vacation buyback remuneration will not be pensionable and will not attach to the employee's base salary. Mr. Hyncik also noted that he communicated to the PSA representatives that the board respects and appreciates the good work they do. Mr. Smith noted this will reduce the amount of carry over vacations days at the end of their employment. Dr. Serafino reported that she is seeing more districts limiting the amount of carry over vacation days allowed and the amount of payout as a result of recent legislation and public sentiment.
